

MINOR PARTICIPANT WAIVER AND RELEASE

I, in my legal capacity as the parent/guardian of the minor(s) named below, do hereby acknowledge and agree that participation in any activities and programs comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with any activity or program participation, including, but in no way limited to: (1) slips, trips, falls, and other injuries, and (2) illness, including exposure to, and infection with, viruses or bacteria.
