

# Public Art Commission Meeting Minutes Tuesday, January 14, 2025 (5:30 pm – 7:00 pm) PACE Center

# 1) Welcome/Roll Call

- 2) Approval of Minutes from November's meeting
  - a) Cindie made the motion to approve the minutes and Dave seconded. The motion was approved unanimously.
- 3) Carryover Projects From 2024
  - a) Carrie went through the 2024 projects that were started but were not able to be completed for various reasons, so the PAC will be working on them in 2025.

- 4) Planned 2025 Projects

- 5) Review of the Public Art Master Plan and Policies
  - a) Our public art consultant Kendall Peterson took the group through the projects that were identified in the "Near Term," and "Short Term" portions of the Public Art Master Plan. We acknowledged the projects that have already been completed and identified ones that need to move based on revised timing. We also have new input on changes and projects from Parks

- and Rec and Community Development and we will use that to update the Master Plan accordingly.
- b) As we ran out of time, the PAC group was asked to review these projects again prior to our next meeting and come ready to discuss the projects they want to focus on in 2025. Once we have that, we will assign budgets and timelines to those projects.
  - The Commission did agree that coming up with Standards and Guidelines for a Mural Program should be a priority, along with developing an artist roster.
- c) The group confirmed that the following Commissioners will be working on the projects below:
  - Michael Lemon Gulch, Rec Center and Parking Garage murals
  - Cindie Mural Standards and Guidelines
  - Cindie and Christine Art in the Park planning, if we end up working with the PAG
  - Hima Artwork Archive assistance

# 6) Budget Discussion

- a) Carrie explained again that there is funding available for Public Art both through the public art GL in the Cultural Fund and through a Reserve Account that rolls over from year to year.
- b) Carrie will share the final 2024 spending at the next meeting, and we will also start putting estimated dollar amounts to the projects we have planned for 2025.

# 7) Decision on "Stop Pushing" sculpture purchase

a) The group discussed the option to purchase this Art Encounters piece. The Commission voted 4 Yes votes to 2 No votes to add it to our permanent collection but requested that we consider finding a better location for it in the future.
