



**Public Art Commission Meeting**  
**Tuesday, March 24, 2026 (5:30 pm – 7:00 pm)**

**Minutes**

- 1) Welcome/Roll Call
  - a) Call to order at 5:32pm
  - b) In attendance: Christine Kennedy, Diana Norton-Stucky, Cindie Perry, Dave Reiter, Michael Montoya, Mark Steinhauser, Hima Mangipudi, Carrie Glassburn (Staff)
  
- 2) Approval of Minutes from February's PAC Meeting
  - a) Dave moved, Cindie seconded, unanimous approval
  
- 3) 2026 Projects
  - Mural Projects
    - o Mural at Keiffer's Crossing (Michael/Mark)
      - Looking to be a summer/fall project, next step is for artist to present a sketch/concept
    - o PACE Parking Garage Mural (Michael/Mark)
      - Bimmer has a timeline established, will start painting west wall in early May
        - Carrie shared issues with painting on the east side due to powerlines. Hopefully a solution will be found.
      - Installation Video (Christine/Cindie)
        - Clarification needed for PAC scope in video project. Will be discuss with Christine and Cindie once we have more info.
    - o Mango Mural (Carrie)
      - Ready to go, just needs enough nice days for Graham to start
  - Public Art Mural Policy (Michael/Cindie)
    - o No progress, Cindie has secured some examples, but is waiting for more people to respond

- Salisbury Park (Dave/Michael)
  - Moving along, but the dedication won't happen until Phase I of the park is complete and we'll do a joint dedication ceremony.
- Town Hall Interior Art Project (Cindie/Hima/Dave)
  - 374 entries were submitted, each person on the selection panel narrowed down their top favorites. We now have 12-13 choices and will be working with the artists to purchase the pieces, find space for each, and get them hung around Town Hall.
- Town Hall Exterior Sculpture Commission (Carrie)
  - Need to decide on where Spiral Vortex is going, based on recommendations from building architects. Commission approves placing Spiral Vortex on pad in front of the former Town Hall entrance.
  - We now need to figure out what sort of piece we want to commission for the new entrance and where to place it, given architectural constraints. Carrie will work with the Town Manager's office to get additional direction and we'll determine next steps.
  - Christine, Diana and Mark offered to work on this project when it moves forward.
- BID Lamp Post Banners (Carrie)
  - We will be switching out banners to Spring/Summer and adding in 16 of the 45/150/250 banners. The concept was shared with the PAC as an FYI.
- Utility Wraps (Diana/Christine/Cindie)
  - PACE Parking Garage
    - Speed Pro has sent a proposal for wrapping the 8 boxes on the east side of the garage. Bimmer will be coming up with a design that will fit with his concepts for the murals on that side. Public Works will hopefully cover the cost of these, allowing us to free up funds to do additional wraps elsewhere.
  - Other Utility Wraps
    - We still have five designs purchased from local artists from last year's call, and we have budgeted to wrap two new boxes.
    - Diana and Christine will take the lead on scoping out new locations and will come back with a recommendation for the Commission and staff to consider.

- Art Encounters (Mark/Christine)
  - o We got 6 new sculptures this year. The locations and pieces were shared with the group.
- Timestones Assessment (Michael/Mark/Carrie)
  - o We received the conservationist report, and they confirmed the deteriorated quality of carvings. The total cost to repair the piece is \$15,311, with ongoing maintenance likely required. Michael will follow up with the consultant on a few questions, and the commission will make a recommendation on next steps at our next meeting.
    - As a reminder, fixing the lighting will cost around \$20k, repairing the sculpture will be around \$15k, and removing the piece and repairing the contract will be around \$13k.
- Plaques (Christine/Dave)
  - o We have pricing and verbiage from FastSigns, and are just making sure the budget allows all 10 plaques to be printed.

#### 4) Budget Review

- a) The group reviewed the projects currently earmarked in the 2026 budget. Carrie will reallocate the purchase of "Spiral Vortex" to come out of the reserve account instead, and allowing us to allocate about \$20k to the murals line item so we can potentially pay for a call, pay a muralist, better fund supplies for some of the larger murals, etc.

#### 6) Possible Future Projects

- Cottonwood/Parker Road Stormwater Improvement Project
  - o No updates
- PACE Crosswalks
  - o Not a top priority
- Salisbury Park Phase II Entryway Sculpture
  - o Will be this year, but waiting to hear from Parks on next steps

- Sculptures at Major Trailheads
  - o The group discussed the option to purchase and move “Possibilities” to McCabe Trail
    - Diana moved to purchase “Possibilities” by John Henley, Mark seconded, unanimous approval.
- Newlin Gulch (Mainstreet and Chambers) murals
  - o Carrie needs to ask for square footage on this and will ask Public Works if there is for available to fund this very large project.
- Horse Mural at Newlin Gulch and Lincoln Avenue
  - o Public Works may also have funding for this extended mural, but we’ll need to wait until later in the year to find out. Once we know there’s money available, we’ll need to reach out to Lutheran to see if they are interested in working on this piece.
- Juniper Building Mural
  - o Another possibility for a mural, but this is not a top priority, as we have many other projects on our plate right now.
